This is different from some of our previous events where we have focused on wines from a particular village produced by different producers to compare the nuance between the different villages and producers.

I am sure you will appreciate that Madame Leroy is probably one of the finest Burgundy producers who is now in her early 80's. She is still extremely active and very much involved in the day to day running of her estate.

The Committee has spent a considerable amount of time in deciding and sourcing her wines for the evening as you could probably appreciate the difficulties in sourcing her wines in good vintages and in the quantities that we need for our annual event. The wines for the evening will include both her Negociant and Domaine bottled wines.
